# **Quick Facts about Sheridan Health Services:**

- Sheridan Health Services has been operating a school-based health clinic for about 20 years, but this clinic opened in 2010 so it's newer to the community. They also have a mobile oral health van.
- Many of the residents in Sheridan and the surrounding communities are low income and have barriers to accessing primary care.
- The Foundation funded the expansion of Sheridan Health Services, a federally-qualified health center (FQHC) at \$770,000.
- The expansion tripled their capacity (30 additional visit rooms and 2 conference spaces) to provide high-quality integrated care to a low-income and vulnerable population.
- The clinic used to serve 2,000 patients and can now serve more than 6,000 annually.
- Two interesting things about this clinic:
  - 1. Its nurse led and managed operated through the College of Nursing (CU). This is helpful considering the physician shortage, especially in a high-needs area.

2.	Clinic users and consumers (their terms) are actively involved in governance, strategic planning and marketing. Look at their <u>board members page</u> and you can see they take engaging with their community seriously.
